Ice Players & Coaches Online Registration

2010-2011 USA Hockey Registration

Arrowhead Youth Hockey Association has teamed up with USA Hockey to allow AYHA participants to directly register online for their USA Hockey membership. By allowing each family to register their players directly online, this will save the Association volunteer time and resources.

***Please Note ** This season, your membership will be valid May 1, 2010- April 30, 2011. If you play ice hockey in the spring, after April 30, 2011, you will need to renew your membership at that time.*

In order to complete your AYHA Registration on June 17th or June 22nd, you will need to complete the following steps:

1. Go to www.usahockey.com and click on the Online Membership tab and then the “register online” button.
2. Choose member type = Ice Player & Coaches
3. You must be 18 years of age to process a registration...Check the box that acknowledges that YOU are 18 or older.
4. Select the correct season = 2010-2011
5. Follow the prompts...fill in all data correctly.
6. Process payment – Visa, MasterCard, Discover or American Express (credit or debit card).
7. \$40.00 Total Fee = \$30.00 USA Hockey Fee + \$10.00 WAHA Affiliate Fee

You may print your Confirmation page at this time. It will also be e-mailed to you immediately after the registration is completed. **You will need this confirmation in order to complete your AYHA Registration process! After open registration, you can submit with your registration or email it directly to secretary@arrowheadyouthhockey.com.**

- ✦ Each participant will pay a total of \$40 if age 7 or older.
- ✦ The USA Hockey fee is waived for age 6 (birth year 2004) and younger but the registration must still be completed to get the confirmation number.
- ✦ Please use your home address for all participants.

LIABILITY RELEASE ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

I, the parent/guardian of a player, a minor, being registered with Arrowhead Youth Hockey Association, also referred to as AYHA, hereby give my permission for him/her to participate in all AYHA activities and to receive any and all qualified emergency medical attention necessary to be administered until such time as I can be contacted. The undersigned does hereby authorize an officer, coach, or agent of AYHA to transport as required, the above mentioned child for any medical attention. The undersigned does hereby assume all risks and hazards incidental to the above-named child's participation in hockey, including but not limited to, transportation to and from any activities, and I do hereby waive, release, absolve, indemnify and agree to hold harmless Arrowhead Youth Hockey Association, its Board member, coaches, sponsors, participants and its agents as well as The Howard G Mullett Ice Center from any and all claims arising out of injury to my son/daughter.

I understand and appreciate that the risk of injury from hockey is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist. By my/my child's participating, I KNOWINGLY ASSUME ALL SUCH RISKS, both known and unknown. Further, I have read, understand, agree to the Waiver of Liability, Release Assumption of Risk & Indemnity Agreement that I acknowledge when registering me/my child with USA Hockey. My registering and making payment to The Arrowhead Youth Hockey Association for fees due for the upcoming season confirms my acknowledgement of this Liability Release Assumption of Risk and Indemnity Agreement.

PAYMENT POLICY

It is agreed that all fees must be paid in accordance with the schedule instituted for the 2010-2011 season. Please note that due to schedules and number of players, the amount due for each player group may be different. All final payments (including 2nd installment payments) are due and payable by November 1, 2010. An additional surcharge of \$75.00 will be payable thereafter unless arrangements have already been made with the AYHA Board. It is agreed that there will be no refund of fees if the above named player or parent is suspended or expelled from AYHA activities, for partial time missed, short term injuries or illness. Players who experience a season ending injury, who are relocated due to a job related transfer, are eligible to receive a prorated refund based on the number of weeks in the season in which they play and/or practice. Once teams are established a player that chooses not to participate will be eligible for a refund of their ice fees, less \$50.00, until the first practice is held. Requests for refunds after the first practice will not be honored. Midget and Bantam level players that are selected to play at the High School level are eligible for a refund of \$450.00 provided that notification is sent to the AYHA Treasurer prior to November 15th, 2010. Any payment, check or credit card, that is returned to AYHA as unpaid by the bank will incur a \$25.00 NSF Fee. All returned payments, including the NSF fee, must be paid immediately by either cash or money order, this includes payments made to the individual team accounts. It is further agreed that by signing this registration agreement I am accepting these terms and will be held responsible for the payment of all fees and assessments and that if the above named player's fees become delinquent, the child shall not be allowed to participate in any association activities.
